The completed pages in this EOI Board Nomination Form will form your EOI Board Nomination pack. Please note **all Sections A, B and C must be fully completed** to be valid for consideration.

- Your EOI Board Nomination pack consists of three parts
 Section A which includes details about yourself, your eligibility for Board Nomination and your skills or relevant experience; and
 Section B which consists of nine (9) questions, followed by
 Section C consisting of nominee name and signature, and two (2) nominating full member names and signatures.
- Section A will form the first page of your Expression of Interest.
 Once your EOI Board Nomination pack is accepted, your address (with the exception of the suburb in NSW), email and telephone number will be obscured prior to forwarding to all eligible voting members, as will any contact details of your referees at question 8 in Section B.
- 3. Please complete all responses using font size 12pt Arial font.
- 4. Please complete **Section A** fully, and answer all nine (9) questions in **Section B**.
- 5. Each one of your nine (9) answers in **Section B** must be answered within the box provided under the question and each answer <u>must be limited to eighty (80) words or less</u>.
